COVID Policy

The Non-Profit Housing Association of Northern California (NPH) is excited to connect in-person at our annual Holiday Member Party happening on December 5 at El Rio San Francisco. The health and safety of all participants (including speakers, venue staff, attendees, volunteers, and NPH staff) is our top priority.

To protect our community, all participants are <u>required</u> to stay at home if they are sick, test positive for COVID-19, have COVID-like symptoms, or have recently been exposed.

Additionally, we *highly encourage* attendees to

- 1. wear a KN95, KF94, or N95 mask while not actively eating or drinking and
- 2. take an <u>at-home COVID test</u> 24 hours before attending the event.

Non-Compliance: Attendees who are unable or unwilling to comply with this policy are asked not to participate or will be removed from the event. No exceptions. No waivers.

In the event that the <u>Centers for Disease Control and Prevention (CDC)</u> and/or the <u>City and</u> <u>County of San Francisco</u> adopt more cautionary guidelines, we'll adjust our policy in accordance.

Detailed information:

Face Covering

NPH encourages all participants to wear masks throughout the entire event while not actively eating or drinking. We recommend a well-fitting **KN95**, **KF94**, **or N95 mask** that completely covers the nose and mouth with no large gap. Attendees are expected to bring their own masks. A limited number of masks will be available on-site. Please note that the venue is both indoor and outdoor.

Symptoms and Exposure

Attendees are required to stay at home if they:

- Are currently testing positive for COVID-19 on the event date,
- Have been in close contact with anyone who tested positive for COVID-19, or who have had COVID-19 symptoms within the last 10 days
- Are experiencing any new or different symptoms that are not related to a pre-existing condition such as: Fever, Cough, Severe headache, Sore throat, Loss of taste or smell, Difficulty breathing/Shortness of breath, Vomiting/Nausea or Diarrhea, Runny nose, or Fatigue or Body Aches

Physical Distancing

NPH asks all participants to respect everyone's physical boundaries and comfort level by requesting and receiving consent before touching another participant.

COVID Assumption of Risk and Waiver of Liability

Despite precautions taken, NPH cannot ensure that you will not be exposed to or contract COVID-19 as a result of participating in this event or related activities. Additionally, you agree to release and hold harmless NPH and its employees, officers, representatives, and agents from any and all alleged and/or actual liability, claims, actions, lawsuits, damages, or losses of any kind which arise out of or result from attendance at and participation in NPH event(s).

You understand and agree that this release includes any claims based on the actions, omissions, or negligence of NPH, its employees, officers, representatives, or agents. Attendee agrees to release and hold harmless NPH and its employees, officers, representatives, and agents from any and all claims, demands, and causes of action arising out of or relating to your participation in the event you are registering to participate in and use of any associated facilities or hotels. If any provisions contained in this agreement shall be invalid, illegal or unenforceable in any respect, under any applicable law, the validity, legality and enforceability of the remaining provisions contained herein shall not, in any way, be affected or impaired.
